October 2020 is the latest month available for SIs as defined (see definition at bottom of page) by SOFA in its report, Severe Injuries to Train and Engine Service Employees: Data Description and Injury Characteristics (July 2001). Feel free to cite, circulate, transmit, reformat, and reference this information, extracted from the FRA's publicly-available, electronic casualty file (6180.55a) on December 30, 2020.

SIs in October 2020: There were 5 SIs in October 2020. All were fractures: 3 to the leg or foot; 1 to the torso; and 1 to various body parts.

SIs Year-to-Date: There have been 43 SIs in 2020, January through October. Six were amputations: 5 to the leg or foot; and 1 to various body parts. Note: SI counts reported herein are provisional, subject to revision. Because of revisions, year-to-date counts may not sum to counts previously published.

Comments: Historically since 1997, January, February, and March are among the highest months for SIs. And these three months represent the highest quarterly counts for SIs. As mentioned in the previous updates, one reason for the increase in these three months is the increase in SIs coded as involving slips, trips, and falls.

Severe Injuries' were defined by the SOFA Working Group as FRA-reportable injuries to train and engine service employees that have a clear and verifiable diagnosis and met one or more of the following four criteria: (1) potentially life threatening; (2) high likelihood of permanent loss of function, permanent occupational limitation, or other permanent disability; (3) likely to result in significant work restrictions; or (4) result from a high energy impact to the human body. (SOFA recognizes that other types of injuries and illnesses cause significant harm to employees.)
