Comments: The July 30, SI involved being struck by a locomotive. Of the 2,186 SIs occurring since January 1997 through July 2020, 135 SIs (6.2 percent) are coded as 'struck by on-track equipment.' Obviously, such events have potential for even greater severity than reported in the July 30 SI.

'Severe Injuries' were defined by the SOFA Working Group as FRA-reportable injuries to train and engine service employees that have a clear and verifiable diagnosis and met one or more of the following four criteria: (1) potentially life threatening; (2) high likelihood of permanent loss of function, permanent occupational limitation, or other permanent disability; (3) likely to result in significant work restrictions; or (4) result from a high energy impact to the human body. (SOFA recognizes that other types of injuries and illnesses cause significant harm to employees.)
